

## OFFICIAL NVC Book Cover Survey Contest Rules – ROUND 4

1. **Introduction:** PuddleDancer Press is offering the NVC Book Cover Survey Contest ("Contest"). NO PURCHASE NECESSARY. A PARTICULAR RESPONSE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.
2. **Eligibility:** Entrant must be 18 years of age as of Aug. 19, 2013.
3. **Timing:** Contest begins at 12:00:01 p.m. P.S.T. on Monday, Aug. 19, 2013, and ends at 11:59:59 p.m. P.S.T. on Sunday, Aug. 25, 2013.
4. **Entry Deadline:** Midnight P.S.T, Sunday, Aug. 25, 2013.
5. **How to Enter:** Click through the "newsletter survey email" sent to you by PuddleDancer Press and complete the eNewsletter Survey. More than one entry from any person or e-mail address will void all entries from that person or e-mail address.
6. **Judging Criteria:** Each entrant selected as a potential winner must complete the survey no later than 11:59:59 p.m. P.S.T. on Sunday, Aug. 25, 2013.
